Notes re Accounts

- Basket/Offertory collections rose in 2023 compared to 2022 thanks to the continued generosity of the community. Thank you also to those who collect at Mass and those who count and lodge the weekly collections.
- Contributions from White Envelope donations also increased in 2023 compared to 2022. Again, thank you to all those who contribute so generously towards the ongoing running costs of the Parish and to those who distribute the envelopes.
- ❖ The Charity Tax Refund Scheme, whereby the Parish can claim back tax relief on donations made by those who are self-employed or PAYE liable, generated a tax refund receipt of €21838.30 for the Parish and continues to be a very important source of income.
- As with any of us who are trying to keep a house or a business running the costs relating to electricity, heating, insurance and other utilities continue to rise and need to be continually monitored.
- The only major repair works/capital expenditure undertaken in the Parish in 2023 was the work completed on the roof in Kilnaspic. A new lawnmower was also purchased in Kilnaspic. The porch and stairs area in Carrigeen Church were painted and some electrical works were also completed. Works were also completed on the heating system in the Parochial House/Office
- It had been hoped to commence the painting of the interior of the Church in Mooncoin in 2023 but this was put on hold until further funding has been raised as this will be a major financial undertaking. Subject to sufficient funding being available this work may be completed this year.
- The sale of the Curate's House in Filbuckstown remains on hold until such time as all legal problems relating to the title have been sorted. The Diocesan solicitors continue to work on getting the title updated and in order and once this has been completed it is planned for the sale of the property to proceed.
